





#### Stochastic Process

A stochastic process is defined as a collection of random variables defined on a common probability space  $(\Omega, \mathcal{F}, \mathbb{P})$ , where  $\Omega$  is a sample space,  $\mathcal{F}$  is a sigma-algebra, and  $\mathbb{P}$  is a probability measure; and the random variables, indexed by some set T, all take values in the same space S, measurable with respect to some  $\sigma$ -algebra.






Marginalization

$$X \sim \mathcal{N}\left(\boldsymbol{\mu}_X, \boldsymbol{\Sigma}_X\right)$$



Conditioning 
$$X|Y=\boldsymbol{y}\sim\mathcal{N}\left(\boldsymbol{\mu}_{X}\right)+\boldsymbol{\Sigma}_{XY}\boldsymbol{\Sigma}_{Y}^{-1}(\boldsymbol{y}-\boldsymbol{\mu}_{Y}),\boldsymbol{\Lambda}_{X}^{-1}\right)$$





$$\Lambda = \Sigma$$



$$X+Y \sim \mathcal{N}\left(\boldsymbol{\mu}_X + \boldsymbol{\mu}_Y, \boldsymbol{\Sigma}_X + \boldsymbol{\Sigma}_Y + 2\boldsymbol{\Sigma}_{XY}\right)$$

## Linear Regression

#### Starting point:

- Locations  $\{ \boldsymbol{x}_i \, | \, i \in [1, N] \}$
- Basis functions  $\{\phi_h(\boldsymbol{x})\}_{h=1}^H$
- Linear model  $y(\phi(x), w) = (w^{\top})\phi(x)^{\times}$
- Prior  $\boldsymbol{w} \sim \mathcal{N}\left(\boldsymbol{0}, \sigma_w^2 \boldsymbol{I}\right)$
- Observation noise  $(t|y) \sim \mathcal{N}(y, \sigma_{\nu}^2)$



#### Gaussian Process

The probability distribution of a function y(x) is a Gaussian process if for any finite selection of points  $(x_1, ..., x_N)$ , the vector  $[y(x_1), ..., y(x_N)]$  follows a Gaussian distribution.



**Problem:** y is a function aka "infinite dimensional vector". But the multivariate


Gaussian distribution is defined for **finite** dimensional vectors.

**Definition:** A GP is a (potentially infinite) collection of random variables such that the joint distribution of **every finite subset** of them is a multivariate Gaussian.

$$t^*|t_1,\ldots,t_N,x_1,\ldots,x_n,x^* \sim \mathcal{N}\left(\mathbf{k}^{\top} \mathbf{C}_N^{-1} \mathbf{t}_N,\kappa-\mathbf{k}^{\top} \mathbf{C}_N^{-1} \mathbf{k}\right)$$




• Class conditionals

#### Prior assumptions:

- Number of classes K
- Class proportions  $\rho \sim \text{Dir}(\alpha_1, \dots, \alpha_K)$
- Class parameters  $\mu_k \sim \mathcal{N}(\mu_0, \Sigma_0) = H^{N}$





We don't! Consider an infinite mixture model.







#### Dirichlet Process

Concentration Parameter/

Given a measurable space  $(S, \mathcal{M})$ , a base probability distribution H and  $\alpha > 0$ , the

probability distribution of  $\frac{1}{4}$  measure G is a Dirichlet process if for any finite partition

$$\{A_1,\ldots,A_r\}$$
 of  $S$ , the vector  $[G(A_1),\ldots,G(A_r)]$   $\sim \mathrm{Dir}(\alpha H(A_1),\ldots,\alpha H(A_r))$ 



#### DP Summary

**Problem:**  $\rho_1$ ,  $\rho_2$ , ... is an infinite dimensional probability vector. But the

Dirichlet distribution is defined for **finite** dimensional spaces.

Definition: A DP is a distribution over probability measures such that for every finite

partition, the probabilities of the partition elements follow a joint Dirichlet distribution.

$$[G(A_1), \ldots, G(A_r)] \sim \operatorname{Dir}(\alpha H(A_1), \ldots, \alpha H(A_r))$$
